General Information:

Dogz Canine Sports Centre would like to invite you to their Rally-O Fun Match, to be held at their facility in Nepean, Ontario. It's a great chance to prepare for trials and practice in a simulated environment. The event will be run according to CARO rules, and will be informally judged - score sheets with comments will be available upon request.

Classes: Novice, Advanced & Excellent (providing there is a minimum entry of 3 in each class). There will be 2 runs offered at the Novice, Advanced & Excellent levels (in that order).

Entries: Can be made in advance by mail, or you can register the day of the event as long as the maximum of 10 dogs per class level hasn't been reached.

Facilities: The Fun Match will be held outdoors in a fully fenced grass ring (no chance of escape!). Washrooms are available, parking is available by the ring, there's plenty of room for tents/crates around the ring, and spectators are more than welcome. The event will still run in the event of rain, but will be postponed if the weather is severe.

Directions:

Dogz ~ 3859 Carling Avenue, Nepean

- From the 417 take the March/Eagleson exit and go north (right if you're travelling west, left if you're travelling east). Turn right at the lights at Hertzberg Road – cross the railway tracks – turn right at the lights at Carling Avenue. Dogz is the first driveway on the left (look for the sign)
- From Carling, go west past Moodie Drive – under the train bridge – Dogz is the last driveway on the right before you get to the lights at Hertzberg Road (look for the sign).



Schedule of Events:

- 9:00 am Check In
- 9:15 am Judges Briefing
- 9:30 am 1st Novice Run

NOTE: There will be 2 runs offered at the Novice, Advanced & Excellent levels (in that order), providing there are at least 3 entries in each level.

Notice to Competitors:

This Fun Match will be run in accordance with CARO rules and regulations - the judge will explain the rules during a Judges Briefing held immediately before the first class at that level. As this is a fun match, there will not be any prizes given, but you will receive your Dog Score Card with comments from the judge for each run you perform. As the purpose of our Fun Matches is to encourage enthusiastic runs in a trial environment, toys and/or treats are allowed in the ring while you are running your dog. There will be a 5 minute maximum applied to all runs to help ensure that the fun match will not be excessively long.

There shall be no refunds for no-shows, or if a dog and/or handler is dismissed from competition - regardless of the reason for such dismissal - or in the event of inclement weather. Refunds will be issued for dogs that come into heat or are injured, providing a veterinarian's certificate is received by the Trial Secretary.

NOTE: For events held outdoors at Dogz, there's acres of mowed trails to walk your dog on leash during the match. We do ask that you poop-n-scoop and keep your dog on a leash at all times when outside of the training rings as there are horses and other wildlife on the property...
